We at AuLP are detailing this month a labor/union inspired Criminal Fraud and bullying of a disabled young 24 year old fellow, causing him to lose in the order of four months' salary, inspired by Labor unionist in the Railway Salaried Officers Union [RSOU], and labor party members at Queensland Rail [QR]. Frank Thomas Heffernan, [[Dossier of: Frank Thomas Heffernan](#) ], the Assistant to C.J. (Joe) Kelso, the then general Manager of the SEQ Region of Queensland in Queensland Rail [QR], and member of the Ipswich Branch of the ALP, had carriage of the matter and ensured that evidence was destroyed, so as not to contradict the perjured evidence of union members.

It involved lying cheating and perjury. Although it happened 33 years ago, the victim, our informant, Haig, has not let it drop because, he says, it is relevant today because of the ideology of labor and unions and because of the identity of some of the people involved.

The disabled guy Haig, was alone and unsupported in Brisbane, and went to the Queensland Law Society Inc. [QLSI], for advice. They referred him to what must have been the most inappropriate person,

given that Haig was the victim of labor/union bullying. They referred Haig to Terry (TJ) Mellifont, prominent labor lawyer who had been then recently disciplined by QLSI. [Mellifont was a few years later struck off the roll of solicitors permanently.] Mellifont owed Haig a Fiduciary Duty [FD]. With Mellifont's strong labor/union "interest", his "representing" was a breach of his FD, as a Conflict of Interest and Duty [CID]. Mellifont should have disqualified himself.

What is even more serious now, [given that Mellifont has been struck-off permanently, (but we still hear of him around), is that the labor lawyer who Mellifont "Instructed" as barrister, has been "promoted". We wonder how many people will be surprised to discover that this promotion has been to be a Judge of the Federal Court of Australia, by the Hawke labor government. The then barrister instructed by Mellifont was Jeffery Ernest John Spender. The full details are covered in detail in the other five journals referenced above.
